On May 1, 2012, St. Luke's Clinic Coordinated Care, Ltd. (SLCCC) was formally organized for the purpose of operating as an Accountable Care Organization (ACO) and to participate in the Medicare Shared Savings Program (MSSP). The MSSP is administered by the Center for Medicare and Medicaid Services (CMS). On December 11, 2012, CMS formally approved SLCCC's application to participate as an ACO in the MSSP, with an effective start date of 1/1/2013. During calendar years 2013-2015, SLCCC's ACO participants will undertake various preventive care programs with eligible Medicare beneficiaries with the goal of accomplishing the following objectives, also known as the "Triple Aim":

The MSSP is a program administered by the Center for Medicare and Medicaid Services(CMS)and CMS must approve all ACO applications. Part of the application process requires that an organization seeking ACO status must first organize itself as a separate legal entity. On December 11, 2012, SLCCC received official approval from CMS to begin operating as an ACO on January 1, 2013. The approved operation period for the ACO is three(3) years. If SLCCC meets the thresholds set by CMS to qualify for reimbursement, then from CMS will reimburse SLCCC in the following manner:
